List made by Celia Renshaw at DRO Matlock on 8 Sep 2015

A series of sheets, fastened together, except for one loose leaf at the end, all showing in full the three oaths taken by each individual, each oath signed by the swearer and the sheet signed at the bottom by the JP confirming the oath (except for item 1). Without additional research, it is not possible to know which of the swearers were non-conformists (but see footnotes). The sheets are in the following order.
